CMV driver states third party heading in opposite direction crossed center line, CMV driver merged to right to avoid collision, in doing so, passenger tires left pavement. Driver overcorrected to return vehicle onto pavement, causing liquid in cargo to slosh and subsequently vehicle rolled onto drivers side, and ended on passenger side. Back check at liquid loading connection damaged and developed small liquid leak.
