INVESTIGATION BY ENVIRONMENTAL CONTRACTOR AND OFFICIALS REVEALED THE LEAKAGE FROM THE MULTI-UNIT TANK CAR TANK WAS DUE TO A BROKEN ELBOW CONNECTOR USED TO ATTACH LOADING AND UNLOADING HOSES BETWEEN THE CARS. IT WAS DETERMINED THE CAR COULD NOT BE REPAIRED IN PLACE. THE CONTENTS OF THE CAR WAS TRANSFERRED TO TANK TRUCKS FOR DELIVERY TO THE CONSIGNEE'S FACILITY ABOUT ONE MILE AWAY.
