WHILE TRAVELING WEST ON I-66 IN VIRGINIA DRIVER NOTICED CLEAR LIQUID SEEPING OUT FROM UNDER DOORS OF VAN. DRIVER PULLED OVER TO CHECK AND REALIZED HE WAS LOSING MATERIAL. HE CALLED ME & I IN TURN CALLED OUR EMERGENCY RESPONSE PEOPLE. ECS ON CALL. THEY DISPATCHED THE LOCAL FIRE DEPT TO CONTAIN THE LEAK. AFTER IT WAS DETERMINED WHERE THE LEAK WAS THE DECISION WAS MADE TO TRANSFER THE REMAINING MATERIAL FROM THE LEAKING COMPARTMENT TO THE TWO INTACT COMPARTMENTS. THEN THE ENTIRE LOAD WAS TRANSFERED TO A LINED TANKER TO CONTINUE ON TO CONSIGNEE'S LOCATION. THE VAN WHICH WAS USED WAS TAKEN TO OUR LOCATION IN WHARTON NJ, TO DETERMINE WHAT THE ROOT CAUSE WAS FOR THE COMPARTMENT FAILURE. IT WAS DETERMINED THAT CAUSE OF LEAK CAME FROM A FAULTY REPAIR MADE BY THE VESSEL MANUFACTURER IN BUFFALO NY. OUR REMAINING TANK VAN VESSELS WERE REMOVED FROM SERVICE AND A COMPLETE INSPECTION WAS MADE PAYING PARTICULAR ATTENTION TO AREA WHERE THE 1ST VAN FAILED. IT WAS DETERMINED THAT BOTH REMAINING VANS WERE SOUND & RETURNED TO ACTIVE SERVICE. WE ARE IN COMMUNICATION WITH THE MANUFACTURER TO MAKE REPAIRS. ON 1ST TANK VAN & TO HAVE THEM MAKE A REPORT AS HOW THE REPAIR WAS DONE & WHY IT FAILED & WHAT CORRECTIVE ACTION IS BEING TAKEN TO ENSURE NO FUTURE FAILURES.
