SOURCES OF LEAK WERE 1) VALVE NOT SEATED/CLOSED (TOP OPERATED BOTTOM OUTLET VALVE PARTIALLY OPEN) 2) NO PACKING UNDER PACKING GLAND NUT ON TOBOV STEM; 3) TWO BOLTS SHEARED OFF FROM THE REDUCER FLANGE TO TANK CAR TANK MOUNTING. VALVE TIGHTENED AND REMAINING BOLTS ON FLANGE TIGHTENED, BUT LEAK WAS NOT FULLY STOPPED. CAR WAS SPOTTED TO FUEL AREA DRIP PADS THEN UNLOADED. CONTAMINATED SOIL WAS REMOVED AND IS BEING AERIATED.
