GATX 46210 WAS NOTED RELEASING PRODUCT FROM THE BOTTOM OUTLET BY CARRIER PERSONNEL. THE CAR WAS ISOLATED OVER A SPILL CONTAINMENT DEVICE AND THE SHIPPER NOTIFIED. SHIPPER REPRESENTATIVES, HEPACO INC, RESPONDED AND FOUND TWO MISSING BOTTOM OUTLET FLANGE BOLTS ALLOWING PRODUCT TO ESCAPE FROM THE DEFECTIVE INTERNAL VALVE. THE CONTENTS OF THE CAR WAS TRANSFERRED TO GATX 46220 FOR DELIVERY. THE DEFECTIVE WAS SHOPPED FOR FURTHER INSPECTION AND REPAIRS MOVING ON AN FRA MOVEMENT AUTHORITY. CC+579 5(5+1+0)X(4+0)=120
