(A B & C) A SECOND VEHICLE WAS OVER THE CENTER LINE CAUSING OUR DRIVER TO VEEER TO HIS RIGHT, OFF THE PAVED SURFACE. (THE AREA IS COMPRISED OF A SERIES OF SMALL HILLS.) HE LOST CONTROL OF HIS VEHICLE, CAUSING THE VEHICLE TO BEGIN A SIDEWAYS SLIDE.
