VEHICLE (PLATE PA-ZLO4812 WAS TRAVELING WEST ON MADISON ROAD AND ENCOUNTERED A NARROW SECTION OF THE ROAD. AS THE DRIVER PROCEEDED THROUGH THE CURVE HE MOVED THE VEHICLE TO THE RIGHT SIDE OF THE ROAD TO AVOID CROSSING THE DOUBLE SEPARATION LINES. AS HE WAS EXECUTING THIS MOVE HE WENT SLIGHTLY OFF OF THE ASPHALT ROADWAY ONTO A VERY WEAK BERM CAUSING THE VEHICLE TO GO OUT OF CONTROL & CROSS THE DOUBLE LINE & TIP INTO A ROLL-OVER STATUS.

THIS ROLL-OVER CAUSED THE PROPANE IN THE TANKER TO GAIN SOME PRESSURE INCREASE & PROPERLY CAUSED THE SAFETY RELIEF SYSTEM TO DO ITS JOB AND RELIEVE SOME OF THE VAPOR THAT HAS BUILT-UP IN THE INTERVAL PIPING SYSTEM. AFTER A SHORT PERIOD OF ABOUT 20 MIN THE SMALL AMOUNT OF VAPOR WAS RELIEVED & THE VEHICLE WAS IN NORMAL MODE.
