SAUX 808 WAS SPOTTED FOR UNLOADING BY CARRIER PERSONNEL WITH NO LEAKS OR RELEASES INDICATED. CONSIGNEE OPERATOR OPENED THE PROTECTIVE HOUSING COVER AND MADE A VISUAL INSPECTION OF THE LIQUID AND VAPOR PRIOR TO COMMENCING THE UNLOADING PROCESS. AFTER THE INSPECTION THE OPERATOR TURNED TO GET THE NEEDED TOOLS AND WHILE HIS BACK WAS TURNED ONE OF THE LIQUID VALVE HANDLES BROKE OFF ALLOWING THE ESCAPE OF LIQUID AND VAPORS. PLANT EMERGENCY RESPONSE PERSONNEL IN ATTEMPTING TO STOP OR CAP THE LEAK. AN ALTERNATE PLAN WAS EXECUTED TO UNLOAD THE CAR INTO AVAILABLE STORAGE TANKS. UNLOADING WAS COMPLETED AT 2130. SITE REMEDIATION EFFORTS CONTINUE UNDER THE DIRECTION OF STATE AND LOCAL AUTHORITIES.
