SEE ATTACHED POLICE DIAGRAM. CARRIER'S VEHICLE WAS TRAVELING NORTH. OTHER VEHICLE WAS TRAVELING SOUTH, RAN OFF THE ROAD, OVERCORRECTED AND CROSSED CENTER LINE CRASHING INTO CARRIER'S VEHICLE, CAUSING IT TO LEAVE THE ROADWAY AND OVERTURN. THE HOLE TORN IN THE CARGO TANK BY THE IMPACT WAS FACING UPWARD WHEN THE VEHICLE CAME TO A REST AND THE CARGO WAS SAFELY PUMPED BY THE CARRIER WITHIN MINUTES OF THE CRASH. BETWEEN 8 AND 12 GALLONS WERE SPILLED FROM THE CARGO TANK AND CONTAINED BY EMERGENCY PERSONNEL UNTIL CARRIER ARRIVED TO RECOVER REMAINING FUEL IN CARGO TANK. ALMOST ALL FUEL ON THE ROADWAY AND SURROUNDING CAME FROM THE VEHICLE ENGINE TANKS FROM BOTH VEHICLES AS THEY BOTH RUPTURED DURING THE COLLISION.

CONSIDERING AN EFFECTIVE 90 MPH IMPACT (45MPH + 45MPH) THE TANK SUFFERED MINIMAL DAMAGE AND ALMOST NO PRODUCT WAS SPILLED. THE ACCIDENT COULDN'T HAVE BEEN AVOIDED BY THE CARRIER. THE OTHER DRIVER WAS A TRAINEE (IN TRAINING AT THE TIME OF THE CRASH). THE REHEARSED RESPONSE OF THE CARRIER (FUEL RECOVERY), AND EMERGENCY PERSONEL DEMONSTRATE HOW A DANGEROUS SITUATION WAS CONTROLLED AND AVOIDED.
