INSPECTION OF THE TANK CAR BY THE CLAREMORE, OK, FIRE DEPARTMENT'S HAZMAT UNIT REVEALED THAT TANK CAR GATX 12079, PHOSPHORIC ACID, 8, UN1805, PGIII, BOTTOM OPERATED BOTTOM OUTLET VALVE CAP WAS OFF AND HANGING FROM ITS SAFETY CHAIN AND THAT THE BOTTOM OPERATED BOTTOM OUTLET VALVE WAS OPEN APPROXIMATELY 10%. HAZMAT RESPONDERES CLOSED THE VALVE AND SECURED THE CAP.
