Describe:

According to the information obtained, the following occurred. While traveling, driver struck a vehicle in front of him, lost control and veered into the center median of the Highway. As a result, the trailer was damaged and caused cargo to shift. The Local Fire Department, Grant County EMA, Wisconsin DOT, and Tegeler Wrecker responded to assess the site. Tegeler Wrecker assisted in recovery efforts, applied absorbent material to the affected roadway and cleared debris from the road. Enviromark was dispatched to perform the cleanup. Upon arrival on site, two 330-gallon totes were discovered damaged. Enviromark pumped approximately 40 gallons of free product from within the totes, and estimated 620 gallons had released to the asphalt roadway and grassy soil within the median. Once Tegeler cleared the road, tote was offloaded and site secured, Enviromark marked the area of impact within the median. A third party consultant was contacted to perform final site remediation, which was coordinated with North Shore Environmental.
