FARM VEHICLE ENTERED ILLINOIS HIGHWAY 3 FROM ROCK ROAD, TRAVELING WEST TO E AST. OUR VEHICLE AND G & G VEHICLE WERE SOUTH BOUND, G & G IN PROCESS OF PASSING COMMERCIAL CARTAGE CO. VEHICLE. FARM VEHICLE HESITATED BRIEFLY AS IT TRAVERSED LANES. G & G UNIT COMPLETED PASS, BUT HAD TO BRAKE TO AVOID COLLISION WITH FARM VEHICLE. NO CONTACT WAS MADE WITH FARM VEHICLE. COMMERCIAL CARTAGE CO. UNIT STEERED RIGHT TO AVOID COLLISION WITH POSSIBLY BOTH VEHICLE AND LEFT ROADWAY. TANKER UNIT THEN WENT OVER A SMALL EMBANKMENT INTO A DEPRESSED SECTION ALONG SIDE OF THE HIGHWAY, OVERTURNED AND BURNED. DRIVER OF FARM VEHICLE WAS ISSUED A TRAFFIC TICKET FOR 'FAILURE TO YIELD'.
