CELX2307 WAS DAMAGED IN A DERAILMENT RESULTING IN THE LOSS OF CONTENTS OF CAR. DAMAGE CONSISTED OF A RAIL PUNCTURE IN TANK HEAD AND THE BOTTOM OUTLET VALVE WAS DRUG OFF DURING THE DERAILMENT. THE CONTENTS OF THE CAR CAUGHT FIRE AT TIME OF INCIDENT AND DUE TO THE NATURE OF THE MATERIAL AND OTHER SAFETY CONSIDERATIONS, THE FIRE WAS CONTROLLED AND ALLOWED TO BURN UNTIL ALL THE CONTENTS WERE CONSUMED.
