When the driver put the evacuation valve on the fill valve the filler valve must have malfunctioned. Propane came out uncontrollably. There was no way to stop the release and all 300 gallons released.

EE called 911- the residence was evacuated and Highway 57 was shut down from 0800 - 1110
