THE KAG MERCHANT GAS GROUP, LLC DRIVER WAS ATTEMPTING TO DELIVER LIQUID OXYGEN INTO THE CUSTOMER'S STORAGE TANK. IN THE COURSE OF DOING SO, AN IGNITION OCCURRED RESULTING IN A SMALL FIRE THAT WAS QUICKLY EXTINGUISHED. AS A RESULT OF DAMAGES TO THE TANK TRAILER, AN UNKNOWN QUANTITY OF LIQUID OXYGEN WAS RELEASED INTO THE ATMOSPHERE. THE KAG MERCHANT GAS GROUP, LLC DRIVER DID SUSTAIN INJURIES AS A RESULT OF THE IGNITION. THE INVESTIGATION INTO THE CAUSE OF THE IGNITION REMAINS ONGOING.
