DRIVER STATED THAT HE HAD SECURED THE SAFETY CHAIN AND HOOK BEFORE THE LOADING PROCESS STARTED. ABOUT TWO THIRDS OF THE WAY THROUGH THE LOADING PROCESS THE SAFETY HOOK CAME UNHOOKED CAUSING THE PRODUCT SPILL. THE SPILL WAS CONTAINED ON THE TRAILER AND THE SCALE PAD. THE SAFETY CHAIN AND HOOK WAS INSPECTED AND WAS IN PROPER WORKING CONDITION. THE CAUSE COULD HAVE BEEN IMPROPER CONNECTION OF THE SAFETY HOOK.
