Company vehicle was travelling east on Old Mt Holly Rd in its lane of travel. V2 was travelling west and crossed the center line, striking the Company vehicle in its power unit fuel tank. V2 driver admitted to being distracted. The collision resulted in the fuel tank rupturing and spilling. Absorbent and booms were placed immediately to contain the diesel from the fuel tank. STAT Environmental responded immediately along with Charlotte Fire Dept.
