ON JUNE 18, 2004, AT APPROXIMATELY 0900 HOURS, A RAILWAY CAR, ACFX 48961, LOADED WITH HAZARDOUS WASTE, SOLID, N.O.S. (K061), 9, NA 3077, PG III, WAS LEAKING FROM AN OPEN "A" END HOOPER DOOR WHILE BEING INTERCHANGED WITH THE NORFOLK SOUTHERN (NS) IN TUSCALOOSA, ALABAMA. KANSAS CITY SOUTHERN RAILWAY (KCSR) DISPATCHED AN EMERGENCY RESPONSE (ER) TEAM TO THE SITE, AND MADE ALL REQUIRED FEDERAL/STATE/LOCAL AND SHIPPER NOTIFICATIONS. THE SHIPPER ARRIVED ON SITE AT 1400 HOURS, AND THE KCSR CONTRACTED EMERGENCY RESPONSE TEAM SECURED THE OPEN HOPPER DOOR. DURING LOADING, THE SHIPPER HAD NOT SEALED THE CLOSED HOOPER DOORS WITH THE CUSTOMARY NUMBERED SEALS; THEREFORE, THESE SEALS COULD NOT BE TIED TO A LOADING DOCUMENT. THE SHIPPER DID INDICATE THAT THEIR STANDARD PRACTICE WAS TO CLOSE THE DOOR LATCH AND SECURE THE LATCH WITH BAILING WIRE. ON JUNE 18 THROUGH JUNE 22, 2004. KCSR USED SEVERAL VACUUM TRUCKS TO RECOVER RELEASED MATERIALS AND CONTAINERIZE INTO VACUUM BOXES FOR DISPOSAL TO CHEMICAL WASTE MANAGEMENT IN EMELLE, ALABAMA. THERE WERE NO INJURIES, AND THE CAR WAS RETURNED TO THE SHIPPER.
