Describe:

Norfolk Southern train Z4QG406 derailed 5 loaded cars of ethanol on Florida East Coast Track at the approach to the bridge over the St. Johns River. One car, KLRX 30940, rolled on its side and began to leak product from the liquid line flange. The other 4 cars, UTLX 205998, FHRX 30695, GATX 18404, and KLRX 30883 were derailed but upright, not leaking. Contractor was called to transfer a portion of the contents of the car (so that it could be picked up) and remediate the area where the ethanol spilled. The Times Union building was evacuated as a precaution.
