Describe:

The release occurred at 2321 S. Anderson Road, Rock Hill, S.C. The location is more appropriately known as the on ramp of SC SR 21 from SC SR 5. The cause of the release was a transportation incident involving a single vehicle rollover a Chemsolv owned and operated truck and semi trailer.

The incident occurred as the Chemsolv was entering South Anderson Road via a cloverleaf from SC SR 5. The truck may have been traveling too fast for conditions and toppled on to its side. The truck contained ten 330-gallon rigid poly Intermediate Bulk Containers (US DOT 31IT11). Each container held 3,500 pounds of 75% Phosphoric Acid. Two containers breached and released 7,000 pounds of the solution. The material has a high viscosity and slowly migrated across the road to gravel/turf shoulder.
