THE PURPOSE OF THIS ADDENDUM REPORT IS TO DOCUMENT THE EVENTS OF A CRASH THAT OCCURRED ON 08/25/03 ON I-72 WESTBOUND AT MILEPOST 41.9. THE IDOT CONTROL NUMBER IS 7849043. THE DISTRICT 20 CRASH REPORT NUMBER IS 20-03-532, AND THE INCIDENT NUMBER IS #15839. UNIT 1 WAS TRAVELING WESTBOUND ON I-72 APPROXIMATELY 0.1 MILES WEST OF MILEPOST 42, WHICH IS LOCATED ON THE TWIN EAGLE BRIDGES WHEN IT APPROACHED TWO OTHER UNITS ON THE BRIDGE THAT WERE BEGINNING TO SET UP THE CONSTRUCTION ZONES ON THE BRIDGE. UNIT 2 WAS ALSO WESTBOUND IN THE DRIVING LINE AND WAS SLOWING DOWN TO PULL OFF ONTO THE RIGHT HAND SHOULDER OF THE BRIDGE. UNIT 3 WAS PARKED ON THE RIGHT HAND SIDE SHOULDER OF THE BRIDGE AND THE DRIVER OF UNIT 3 HAD ALREADY EXITED THE VEHICLE AND WAS WALKING ON THE RIGHT HAND SHOULDER. THE DRIVER OF UNIT 1 ADVISED HE DID NOT SEE THE UNIT 2 IN FRONT OF HIM UNTIL IT WAS TOO LATE. UNIT 1 THEN SLAMMED ON THE BRAKES AND BEGAN SKIDDING. UNIT 1 REAR ENDED THE TRAILER BEING PULLED BY UNIT 2 WHICH CAUSED UNIT 2 TO BREAK AWAY FROM ITS TRAILER AND OVERTURN ONTO ITS SIDE. UNIT 1 THEN SIDESWIPE UNIT 3 WHICH WAS PARKED ON THE SHOULDER AND THEN HIT THE DRIVER OF UNIT 3, WHOM WAS A PEDESTRIAN ON THE BRIDGE. UNIT 1 THEN SWERVED AND HIT THE SIDE OF THE BRIDGE ON THE RIGHT HAND SHOULDER WHERE IT CAME TO REST AND CAUGHT ON FIRE. UNIT 2 CAME TO REST IN THE PASSING LANE ON ITS PASSENGER SIDE AND ALSO CAUGHT ON FIRE. UNIT 3 REMAINED PARKED ON THE RIGHT HAND SHOULDER AND THE DRIVER OF UNIT 3 WAS LOCATED ON THE RIGHT HAND SHOULDER AFTER HE WAS STRUCK BY UNIT 1.
