PART TIME DOCKWORKERS DAN BARTNUK & DANIEL KONITSKY OPENED TRAILER TO A FAINT SMELL. UNLOADED ALL FREIGHT UP UNTIL LAST 2 DRUMS IM THE FRONT LEFT OF THE TRAILER WITH NO PALLET. SITTING ON A SMALL SHEET OF CARBOARD. A EMPTY SKID WAS PLACED NEXT TO IT IN ORDER TO SAFELY ROLL THE DRUM ONTO IT. THEY TRIED TO ROLL THE DRUM ON THE RIGHT WHICH IMMEDIATELY BEGAN TO POUR LIQUID. THEY QUICKLY LEVELED IT ONTO THE PALLET TO PREVENT FURTHER LEAKAGE AND EVAGUATED THE TRAILER AND ALERTED SHAWN ELDRIDGE WHO HAD THEM IMMEDIATELY CLOSE THE DOOR AND STAY CLEAR UNTIL NOTIFICATION.
