DPC TRAILER CAUGHT ON FIRE WHILE MAKING DELIVERIES. OUR DRIVER ATTEMPTED TO QUENCH FIRE WITH EXTINGUISHER, BUT WAS UNSUCCESSFUL. THE FIRE RE-IGNITES CAUSING THE FUSE PLUGS ON (3) TON CONTAINERS TO MELT. DPS WAS CLEARING AN AUTO ACCIDENT AT THE INTERSECTION AND CONTACTED 9-1-1 OF THE FIRE. DPS CLOSES THE ROADS TO TRAFFIC AND EVACUATES NEARBY BUSINESSES AND RESIDENCES. LIBERTY HILL VFD RESPONDED AND EXTINGUISHED THE FIRE. THE DPC DRIVER NOTIFIED CLEBURNE OFFICE AND RESPONSE TEAM WAS SENT. UPON ARRIVAL, THE TEAM DONNED EMERGENCY RESPONSE GEAR. THEY REPLACED FUSE PLUGS ON (3) TON CONTAINERS. ALL TON CONTAINERS WERE TRANSFERRED TO ANOTHER TRAILER FOR TRANSPORT TO DPC FACILITY. THE DAMAGED TRAILER WAS TOWED AWAY AND HIGHWAY WAS OPENED FOR TRAFFIC. THE INVESTIGATION DETERMINED THAT FRICTION CAUSED BY A FLAT TIRE CAUSED THE FIRE ON THE TRAILER WHICH MELTED THE FUSE PLUGS CAUSING THE RELEASE OF CHLORINE.
