Describe:

Evidence at the scene and statement of the Driver indicates the following occurred: The Driver was traveling south on Cabin Creek Road, Cabin Creek, WV, when he ran off the road on the right side. He attempted to regain control of the vehicle while off the roadway and it overturned coming to rest in the middle of the roadway. The roll-over caused the Diesel Fuel tank to rupture spilling 300 gallons of diesel fuel.

Describe:

Driver re-training. The Driver's description of the accident was that he allowed his right front tire to run off the shoulder of the road where there was a significant drop off from the pavement. In his attempts to steer the truck back onto the road, he lost control of the steering which resulted in the truck weight shifting and causing the subsequent roll-over. This incident was a result of Driver error, and therefore, we have re-instructed the Driver and all other Drivers that travel that route to be cautious of the low shoulders.
