ACCORDING TO THE INFORMATION OBTAINED, THE FOLLOWING OCCURRED. WHILE BEING LOADED APPROXIMATELY 850 GALLONS OF PRODUCT WERE RELEASED DUE TO A FAULTY VALVE ON THE LINDEN BULK TANKER. THE FREE LIQUID IMPACTED THE CONTAINMENT AREA UNDER THE SCALE AT THE TERMINAL. THE TERMINAL DISPATCHED A COMPANY TO RECOVER THE FREE LIQUID. NO ADDITIONAL CLEANUP WAS REQUIRED. NO INJURIES OR EXPOSURES WERE REPORTED.
