At 5:20 AM Univar Driver reported a strong odor and fume cloud coming from the right side of trailer. 911 was called along with cleanup contractor SWS and crew was dispatched. The trailer was parked on the shoulder of SR 60 West bound. The top half of the drum had split at the seam. The leaking drum was overpacked along with all the other drums of the same waste stream. The soil around the spill area was removed and properly disposed of per state and federal regulations.
