ON MARCH 25, 2001 AT APPROXIMATELY 13:00, ACFX 89616, A LOADED TANK CAR OF SODIUM HYDROXIDE SOLUTION, WAS INVOLVED IN A SIDE SWIPE COLLISION IN THE CSX TRANSPORTATION YARD IN GADSDEN, ALABAMA, MILEPOST OLE 454.0 AN EMPTY WOOD CHIP HOPPER CAR, CSXT 433716, DERAILED AND STRUCK ACFX 89616, WHICH WAS SITTING STILL ON AN ADJACENT TRACK. ACFX 89616 WAS STRUCK IN THE B- END, RIGHT SIDE CAUSING THE TANK TO OVERTURN. THE CAR LEAKED APPROXIMATELY 10 GALLONS OF PRODUCT FROM THE VACUUM RELIEF DEVICE OF WHICH APPROXIMATELY 9 GALLONS WAS CONTAINED IN BUCKETS. THE CAR WAS UPRIGHTED AND THE LEAK STOPPED. NARRI=300 CODE=242
