A DERAILMENT OCCURRED ON JANUARY 29, 2001, AT APPROXIMATELY 0320 HOURS. CAR TILX 160123, CONTAINING SODIUM HYDROXIDE SOLUTION WAS ONE OF THE 28 CARS THAT DERAILED. AT 0830 HOURS THE SIGNAL DESK WAS NOTIFIED THAT THE CAR WAS LEAKING. THE MISSOURI EMERGENCY RESPONSE OFFICE, FEDERAL RAIL ROAD ADMINISTRATION, NATIONAL RESPONSE CENTER & US COAST GUARD, AND THE SHIPPER WERE NOTIFIED. THE CAUSE OF THE DERAILMENT IS STILL UNDER INVESTIGATION.
