THE KAG SPECIALTY PRODUCTS GROUP, LLC DRIVER WAS PREPARING TO INITIATE HIS DELIVERY OF POTASSIUM HYDROXIDE INTO THE CUSTOMER'S STORAGE TANK. THE DRIVER NOTICED A MINOR LEAK COMING FROM THE EXTERNAL VALVE OF THE TRAILER. AS THE DRIVER WAS ATTEMPTING TO REPAIR THE EXTERNAL VALVE. POTASSIUM HYDROXIDE BEGAN TO ESCAPE FROM THE TRAILER AT A MUCH MORE RAPID PACE. THE DRIVER WAS UNABLE TO STOP THE FLOW OF PRODUCT AND APPROXIMATELY 45,125 LBS OF POTASSIUM HYDROXIDE WAS RELEASED, IT APPEARS THAT THERE WAS ALSO AN ISSUE WITH THE TRAILER'S INTERNAL VALVE THAT WAS ALLOWING PRODUCT TO ESCAPE. A PORTION OF THE SPILLED POTASSIUM HYDROXIDE WAS ABLE TO MIGRATE TO A NEARBY STORM DRAIN. HEPPAXO ENVIRONMENTAL RESPONDED TO THE SCENE AND HANDLED THE REMEDIATION. NO FURTHER ENVIRONMENTAL IMPACT IS ANTICIPATED.
