A LINDE VEHICLE CARRYING LIQUID OXYGEN WAS TRAVELING WEST ON I 30 IN THE RIGHT-HAND LANE NEAR MILE MARKER 192 WHEN AN UNIDENTIFIED VEHICLE VEERED INTO ITS LANE. THE LINDE DRIVER VEERED RIGHT TO AVOID CONTACT. UPON DOING SO, THE RIGHT STEERING TIRE STRUCK THE GUARD RAIL, CAUSING THE TRACTOR AND TRAILER TO STRADDLE THE RAIL. THE VEHICLE REMAINED ON THE RAIL FOR APPROXIMATELY 350 FEET BEFORE IT FELL OVER THE SIDE OF THE BRIDGE INTO THE CREEK BELOW. APPROXIMATELY 100 GALLONS OF DIESEL FUEL, ENGINE OIL, AND HYDRAULIC FLUID WERE SPILLED, AS WELL AS 527000 CU FT OF PRODUCT THAT WAS VENTED. LINDE PERSONNEL, IN COOPERATION WITH STATE AND LOCAL AGENCIES, CLEANED AND DECONTAMINATED THE AREA TO THE SATISFACTION OF THE BOWIE COUNTY ENVIRONMENTAL AGENT. THE DRIVER OF THE UNIDENTIFIED VEHICLE DID NOT STOP.
