On 09-05-2017, at 00:48 hours, personnel in the CSXT Greenwood Yard discovered PROX 91628, a loaded tank car of Carbon Dioxide, leaking from the top of the car. The car was isolated and Praxair, South Carolina DHEC No report number given and NRC report# 1189356 were notified. CHEMTREC Report #2017-09-05-00001. HEPACO, a CSXT emergency response contractor, was dispatched to the scene and found the liquid valve (Rego Valve TA 7894B) open and the secondary closure plug hanging from the chain. The issue was identified and corrective actions were communicated to the shipper Michael Bolton Ph#716-879-2446. Contractor personnel closed the liquid valve and put the secondary closure plug back on. The leak was secured and the car was released for transport. This incident did not require a special switching move.

Cause Code: 134 Liquid Valve, 308 Leaked, 526 Loose Closure
