Describe:

On July 1, 2015, at 23:51 hours the Blount County Communication Center reported a tank car on fire CSX Mile Post 00C 290.62. CSX personnel responded and found that the south bound Train S 54101 had derailed and de-trucked the A-end of tank car UTLX 901717, a loaded tank car of Acrylonitrile, Stabilized. Damage incurred during the derailment included cracks to the AR and AL lower portions of the tank shell; this damage resulted in product release and a subsequent fire. The shipper, INEOS USA LLC, was notified via CHEMTREC Report 2015-0702-00010. Once the car was empty and the fire had been extinguished the breached tank car was removed from the railroad, clean and purged, and secured pending any further investigation.
