DRIVER LOOKED AT GAUGE ON TANK IT READ 11'10" TANK IS AT 17' TANK DRIVER CALCULATED LOAD WOULD BRING TANK TO 16'8" TANK. STARTED OVERFILL OUT OF THE TOP DRIVER SHUT DOWN UNLOADING DRIVER LET TANK SETTLE DOWN. ABOUT 200 GALLONS CAME OUT OF TOP OF TANK.
