FEARING THAT HE HAD RUN OFF THE ROAD HE OVER CORRECTED, LOOSING CONTROL OF THE VEHICLE AND THEREBY CAUSING THE ROLL OVER. THE AREA WAS DIKED TO PREVENT RUN OFF. ANOTHER JAS TRANSPORT UNIT ALONG WITH A COMPANY CREW WAS DISPATCHED TO TRANSLOAD THE TRAILER. GARNER ENVIRONMENTAL WAS POTENTIALLY CONTAMINATED SOIL WAS REMOVED AND DISPOSED OF. ADDITIONAL SOIL SAMPLES WERE TESTED BY A & B ENVIRONMENTAL TO ENSURE ALL CONTAMINATION WAS REMOVED FROM THE ACCIDENT SITE. THIS REPORT WAS PROVIDED TO TNRCC. A COPY OF THE GARNER ENVIRONMENTAL REPORT AND A&B ENVIRONMENTAL'S REPORTS ARE ATTACHED.
