Describe:

While making a bulk delivery at Mesa Consolidated Water, driver overfilled the tank approx 200 gallons of 25% Caustic spilled in a secondary containment.

Tank level indicator was in a control room away from the tank. Before the bulk driver could stop pumping the product, approx 200 gals of product spilled into the secondary containment through a 4" overflow. The customer was on his way to inform the driver to shut off delivery valve when the spill started to occur. It seems like the customer ops personnel did not know the available capacity of the tank at the start of the delivery and mis-informed our driver about the available capacity of the tank.

Lack of knowledge of the tank capacity was the root cause of the incident.
