MANION ENV CORP OUT OF CHATTANOOGA RESPONDED TO THE SPILL AND USED LIME TO NEUTRALIZE THE WHOLE SPILL AREA. THEY ALSO MADE ARRANGEMENTS FOR DISPOSAL AND REMEDIATION. NO INJURIES REPORTED. THE NRC WAS NOTIFIED AS WELL AS TNDEC.
