Describe:

Driver was delivering propane to customers leased tank when he heard a loud noise. He checked the truck and saw liquid leaking from the belly of the bobtail. He hit the emergency shut down but the leak didn't stop. The driver called me the District manager and I responded to the scene. I saw the truck engulfed in a propane cloud. I called 911 and started evacuating the nearby houses. When the fire department arrived they set a hose line and fogged the truck with water. The Hazmat team wrapped a wet cloth around the leak and slowed it considerably. When the leak slowed they were able to disconnect the arm from the belly valve which allowed the valve to close and the leak stopped.
