TRUCK WAS EAST BOUND ON PA TURNPIKE WHEN IT STRUCK A STEEL TANK WHICH HAD BEEN DROPPED ON THE HIGHWAY BY A TRUCK IN FRONT OF IT. THE IMPACT THREW THE TRUCK INTO THE CONCRETE LANE DIVIDER CAUSING IT TO OVERTURN. THE TRAILER WAS PUNCTURED AND RUPTURED CAUSING THE CARGO TO SPILL ON THE HIGHWAY. PENNSYLVANIA STATE POLICE DISPATCHED HAZ MAT AND EMERGENCY TEAMS TO THE SCENE. RAW OIL DISPATCHED A TRUCK AND RECOVERY TEAM TO RECOVER PRODUCT LEFT IN THE TANK.
