The driver was traveling North bound on LA SH 165, approximately 2 miles south of Glenmora, LA. The tractor/trailer appeared to have both left the roadway for several hundred feet, before appearing that tractor was attempting to get back on paved surface, while trailer was still in the ditch. The tractor/trailer skidded on back wheels in a sideward motion across both N. bound lanes. Total gallons 6700, approx 5,200 gallons recovered immediately after the accident.
