Describe:

A TANK CAR (GATX 90658) CONTAINING 50% SODIUM HYDROXIDE WAS CONNECTED BY THE UNLOADING LINE TO AN UNLOAD PUMP ADJACENT TO THE RAILROAD TRACK. THE CAR WAS ON THE SWITCH LIST AS AN EMPTY AND WAS TO BE PULLED FOR RETURN TO VENDOR. THIS CAR WAS NOT EMPTY. THE BLUE FLAG HAD BEEN REMOVED BY THE OPERATOR IN CHARGE OF UNLOADING. THE CN SWITCH CREW CAME IN TO SWITCH THE CARS AND DID NOT NOTICE THAT IT WAS STILL HOOKED UP. THEY REMOVED THE WHEEL CHOCKS AND COMMENCED TO PULL THE RAILCAR FROM THE UNLOAD SPOT. THE FLEX HOSE USED FOR UNLOADING SNAPPED AND SODIUM HYDROXIDE SPILLED FROM THE RAILCAR UNTIL THE INNER VALVE WAS CLOSED BY THE OPERATOR IN CHARGE OF UNLOADING. A NEW OPERATING PROCEDURE WAS WRITTEN WHICH ONLY ADDRESSED SWITCHING ISSUES. THIS PROCEDURE REEMPHASIZED THE FACT THAT FLAGS AND DERAILS ARE NOT TO BE REMOVED WHILE CARS BEYOND THEM ARE STILL CONNECTED. ALL UNLOADING OPERATORS AND OTHER PERSONNEL INVOLVED WITH SWITCHING OR UNLOADING WILL BE TRAINED ON THIS PROCEDURE. REFRESHER TRAINING WILL ALSO BE GIVEN COVERING GENERAL TANK CAR LOADING/UNLOADING PROCEDURES.
