First Call Environmental was dispatched to the site. Upon the , personnel observed that the released material impacted an area measuring approximately 53ft-by-8ft of the trailer floor and 53ft-by-8ft of the asphalt roadway and estimated that one hundred and thirty (130) gallons of material was released due to one (1) 330-gallon poly tote crushed. The remaining product in the damaged tote was transferred to a new tote and shipped on. First Call Environmental personnel deployed a neutralizer to the impacted areas and then used a granular absorbent to the areas. The spent material was recovered and containerized into two (2) 55-gallon poly drums. One (1) 55-gallon poly drum of recovered product was generated, and the cut-up tote was placed into one (1) additional 55-gallon poly drum. One 55-gallon poly drum was generated of neutralized liquid material recovered from the impacted areas. The generated waste was transported offsite for disposal.
