K & O TRAIN WAS PULLING INTO HUTCHINSON WITH 76 CARS. TRAIN WENT INTO EMERGENCY. ENGINEER STOPPED THE TRAIN WALKED BACK AND FOUND THREE CARS DERAILED. CARS DERAILED PRIMARILY FOR BROKEN RAIL AND CONTRIBUTING CAUSE OF DETAILED FRACTURE OF TRACK. ONE TANK CAR OVERTURNED, SECOND WAS DERAILED BUT REMAINED UPRIGHT, AND THIRD CAR WAS UNTRACKED AND FELL TO THE GROUND. FIRST CAR LEAKED CONTENTS ON THE GROUND, SECOND CAR (CONTENTS) PUMPED INTO TRUCKS; (SENT) BACK TO SHIPPER. HAZMAT RESPONSE CONTAINED SPILLAGE TO IMMEDIATE AREA. EVACUATED NEARBY HOMEOWNERS THAT NIGHT; ALLOWED BACK TO HOMES LATE THE FOLLOWING EVENING IN CASE OF EXPLOSION.
