BURNING PACKAGE DISCOVERED AT 8:33PM BY PICK-OFF LINDSEY GONZALES. HE YELLED "FIRE" AND SUPERVISOR BEN MOGAB CLEARED THE AREA, AND LINDSEY GRABBED A FIRE EXTINGUISHER AND TRIED TO OUT OUT FIRE WHICH IMMEDIATELY RE-IGNITED. AT 8:35PM THE EVACUATION ALARM SOUNDED AND RANDY LIMBAUGH OF THE PE DEPARTMENT SENT LINDSEY OUT OF THE BUILDING, SECURED THE AREA, AND CONITNUED TO CONTAIN, AND TRY TO EXTINGUISH THE FIRE. THE FIRE DEPARTMENT ARRIVED AT 8:50PM AND WERE ABLE TO EXTINGUISH THE FIRE WITH 2 1/2 EXTINGUISHED AND PRESSURIZED WATER FROM THEIR HAND HELD CONTAINERS. THE BUILDING WAS RELEASED AT 9:40PM AT WHICH TIME THREE UPS DESIGNATED RESPONDERS WERE DISPATCHED TO CLEAN-UP THE SPILL CONTENTS AND BELTS. ALL ARRIVED IN PROPER PPE, USED DECISION TREE'S AND PH TAPE, AND CLEANED THE SPILLED CONTENTS AS WELL AT THE DEBRIS FROM THE BELTS AND FLOORS. THE AREA WAS RELEASED FROM THE UPS RESPONDERS AT 10:05PM, AND ALL DAMAGES WERE RETURNED TO THE DMP PROCESSING FOR PROCESSING.THE CAUSE OF THE FIRE WAS A STATIC DISCHARGE.
