UPON TAKING SAMPLE FROM REAR, OPERATOR RECOGNIZED OBSTRUCTION IN TUBING. THEY REMOVED THE EXTERNAL VALVE AND BEAT ON THE REMAINING PIPING TO REMOVED OBSTRUCTION, WHICH TURNED OUT TO BE ICE FROM THE SODIUM HYDROXIDE SOLIDIFYING DUE TO COLD WEATHER. WHEN THE ICE GAVE AWAY, A PIECE OF THE ICE STUCK IN THE SEAT AREA OF THE EXTERNAL VALVE, PREVENTING IT FROM CLOSING. THE LIQUID THEN RAN ONTO THE CRUSHED ROCK SURFACE AND WAS CONTAINED BY EARTHEN DIKES. CLEAN UP WAS CONTRACTED WITH AN INDEPENDENT ENVIRONMENTAL ENGINEERING FIRM, WHO ALSO FILLED ALL EPA AND OSHA REPORTS
