A CEVA Logistics Tanker was involved in a single vehicle collision with a CSX train resulting in the release of approximately 1467 gallons of diesel fuel to a section of asphalt roadway, a section of dirt roadway and an on site creek adjacent to the rail road tracks. CSX personnel coordinated all response, remediation and disposal activities. CSX personnel trans-loaded the remaining diesel fuel from the over turned tanker into a replacement tanker on site (approximately 5933 gallons)
