CAR BY PASSED COUPLER CAUSING DRAW HEAD OF NATX 23517 TO PUNCTURE B-END OF HOKX 111626 WHILE HUMPING IN TRACK C-12 OF CSXT'S BOYLES TERMINAL. APPROXIMATELY 10 GALLON PER MINUTE LEAK ENSUED. 11,000 GALLONS FROM HOKX WERE TRANSLOADED INTO GATX 58324, WITH APPROX 4800-5000 GALLONS SPILLED INTO RAILROAD BAUAUST. 2000 GALLONS WERE RECOVERED BY DIGGING TRENCHES IN BAUAUST AND PUMPING PRODUCT OUT. THE REMAINING 2800-3000 GALLONS WERE NEUTRALIZED WITH A 5% HCL SOLUTION. RECOVERED MATERIALS WERE ROUTED TO OCCIDENTAL CHEMICAL, MUSCLE SHOALS, ALABAMA FOR REPROCESSING. NATIONAL RESPONSE CENTER NOTIFIED 00:26, REPORT #33188. ALABAMA TROOPERS NOTIFIED 00:15, WITH A.D.E.M. RESPONDING TO SCENE.
