Describe:

Customer refused shipment of portable tank because of the outer metal cage's condition (rusted frame). While off loading from flatbed trailer the forklift blades pushed the metal cage bottom up into the valve. The valve failed and the contents were lost. Before the material was contained approx. 10 gallons was lost in our storm drain. The drain was dormant and the acid was contained in the one drain. The drain was pumped dry and then flushed with a soda ash solution to neutralize and then flushed with clean water. All flushings were pumped and disposed of. Spill mats will be moved to the loading dock for faster future response. All portable tanks of this style are being reevaluated for cage condition and will be scrapped if not acceptable.
