THE METHANOL WAS DILUTED WITH WATER AND PUMPED INTO A 500 BBL FRACTANK. THE METHANOL WAS THEN TREATED IN OUR TREATMENT PLANT. THE LOADING EQUIPMENT MALFUNCTION WAS IDENTIFIED AND CORRECTED.
