Describe:

At 1117 ET XPO Terminal UPH notified ERTS of a release of UN1908 "CL-25 SOL 31.25" from a 330 gallon tote due to a piece of metal puncturing it, impacting the trailer floor and yard. ERTS dispatched GrayMar to conduct cleanup.

At 1225 ET, GrayMar arrived onsite and confirmed 200 gallons of product released to a 43' x 36' area of the asphalt lot and a 53' x 8' area of the trailer floor. Absorbents were worked into the impacted areas and then collected. Once removed, a vac truck was utilized along with a pressure washer to clean residual material. The damaged tote was then cut up and containerized. All waste was placed into 2 poly totes and (10) 55 gallon poly drums. All waste was staged onsite for terminal personnel to manage.
