OUR LOGEX DRIVER WAS TRAVELING NORTH ON 159 CHANGING TO US 98E WHEN HE NOTICED VAPOR AT THE REAR OF THE TRAILER. THE WEATHER WAS RATHER HUMID AND A LIGHT MISTY RAIN FALLING, WHICH MADE IT DIFFICULT TO RECOGNIZE THE VAPOR FROM THE ROADS PRAY. THE DRIVER INVESTIGATED AND FOUND THAT THE BOTTOM FILL VALVE HAD VIBRATED OPEN AND WAS FROZEN OPEN, MAKING IT IMPOSSIBLE TO CLOSE. A FIRE TRUCK WAS DISPATCHED TO THE SCENE AND WATER WAS USED TO THAW THE VALVE, THE VALVE WAS THEN CLOSED AND THE DELIVERY COMPLETED WITHOUT FURTHER INCIDENT. THE TRAILER WAS THOROUGHLY INSPECTED UPON ITS RETURN TO THE TERMINAL AND THE VALVE WAS OPERATING NORMALLY. OUR INVESTIGATION INDICATED THAT MOISTURE FOUND ITS WAY INTO THE BONNET AND SEAT, WHICH FROZE WHEN THE VALVE VIBRATED OPEN AND CRYOGENIC LIQUID CONTACTED THE VALVE.
